TO: Psychologists Interested in Performing Examinations in Probate Court Matters

RE: Panel of Psychologists Maintained by the Office of the Probate Court Administrator

The Office of the Probate Court Administrator (PCA), which oversees Connecticut's Probate Courts, maintains a list of psychologists who are willing to perform examinations in various probate court matters. By statute, psychological examinations are conducted in: 1) placement matters involving persons with intellectual disability (C.G.S. section 17a-274) and 2) sterilization matters involving persons unable to give informed consent (C.G.S. section 45a-695). The Probate Courts may also appoint psychologists under C.G.S. section 46b-150a(c), which deals with emancipation of minors, and under C.G.S. section 45a-132a, as appropriate, to examine allegedly incapable parties in "any matter before a probate court in which the capacity of a party to the action is at issue."
