The unmarried person is defined as a "minor or minor child" under C.G.S. section 45a-616 (f) (2).
- 2) The petition shall be filed in the probate district in which the 18 to 20-year-old resides, is domiciled or is located. Also file PC-5013C, Confidential Information sheet, which is the last page of this petition.
- 3) For more information, see C.G.S. sections 45a-608n, 45a-616 and 45a-617.
- 4) Type or print the form in ink. Use Second Sheet, PC-180, or an additional sheet, if more space is needed.
