Review of concepts for revision for the 2026 edition

The Committee began to review the proposed concepts for rules presented at the last meeting. The full committee offered feedback on the following topics:

- Regarding electronic signatures under Rule 1.1(15), the full committee discussed
 the concept of allowing, as an electronic signature, the practice of court users
 typing their name on probate court forms. After discussion, the proposal was
 tabled for further discussion.
- Regarding the applicability of the Probate Court Rules of Procedure to probate appeals under Rule 2.2, the proposal was tabled for further discussion.
- Regarding the concept of adding the Department of Veterans Affairs to Rule 6.1, there was full consensus that draft language should be prepared and reviewed for incorporation in the 2026 revisions.
 - Regarding streamline procedures under Rule 8.6, the full committee considered the concept of adding petitions for parentage orders under Rules 40.24 (assisted reproduction) and 40.25 (gestational surrogacy). After discussion, there was consensus that not to revise the rule to include these petitions for streamline.
- Also regarding streamline procedures under Rule 8.6, the committee discussed a
 general proposal to include other matters for inclusion under Rule 8.6(h). After
 discussion, the proposal was tabled for more information.
- Regarding the proposal to eliminate Rule 12.3, after discussion, the committee reached consensus to make no changes to the rule.
