Probate Court Rules Advisory Committee

The meeting was convened at 3:06 p.m. by Hon. Beverly Streit-Kefalas, Probate Court Administrator and Chair.

Remarks of the Chair

Judge Streit-Kefalas thanked the committee members for their continued energy and commitment. The work of the Advisory Committee is one of the best processes in the system. The development of the Probate Court Rules of Procedure is not just for uniformity and consistency, but also to allow for meaningful access to the courts by self-represented parties.

Approval of minutes of September 5, 2023 meeting

The minutes of the September 5, 2023 meeting were reviewed and approved by all members of the committee present at the meeting without change.

Continued review of concepts for revision for the 2024 edition

The committee continued to review the proposed concepts for rules from the last meeting. The full committee offered feedback on the following topics:

- Regarding petitions for restoration of a person under involuntary conservatorship, the full committee discussed the issue and the need to have plainly-written language setting forth the process and procedure to request restoration. No such language exists in the statute. The consensus of the full committee is to draft language and have continued discussion.
- Regarding uniform procedures for probate bonds, the full committee noted that
 there does not appear to be a clear statement of process and procedure in the
 courts regarding the consideration and implementation of a bond after the initial
 petition. After discussion, the full committee, by consensus, determined that the
 language of Rule 35.8 should be revised and expanded to address this issue.
- Regarding procedural changes to reinstatement of parents or guardians in guardianship of minor proceedings, the full committee discussed the need to clarify and potentially modify Rule 40.7 to comply with the court decisions of *In re Zakai*, 336 Conn. 272 (2020) and *In re Paulo T.*, 347 Conn. 311 (2023). The committee will continue discussions with drafted language to be reviewed.
- Regarding foreign subpoenas, the full committee noted the recent adoption of the uniform Interstate Depositions and Discovery Act at General Statutes § 52-655, et seq. By consensus, the full committee determined that language should be drafted for incorporation in the 2024 revisions.
- Finally, regarding participation in probate hearings by electronic means under Rule 66, Judge Streit-Kefalas introduced the concept as a good issue to discuss as the rule was developed and debated extensively during the last revision. A review and discussion of how the rule has since performed will occur at the next meeting.
