# 5. Comments of the Probate Court Administrator:

Judge Streit-Kefalas reported on the following:

- a. The Honorable Raheem L. Mullins has been approved by the Judiciary Committee to serve as the interim Chief Justice with full approval to go before the legislature when it convenes in January 2025. In his testimony before the committee, he remarked on the importance of technology improvements from its eFiling system to its public website, with attention to ensuring access for the public. The Probate Court system has already been addressing many of these issues with current projects in progress to update the website and a redesign of CMS and cybersecurity upgrades.
- b. Cybersecurity is a critical concern for all systems, including ours. The IT Department is developing an awareness training program for all users. Please caution all staff on the policies surrounding proper use of email.
- c. The National Center for State Courts has many free educational resources that judges should consider.
- d. Court visits are being conducted. A few issues discovered are:
  - State marshals who are still serving facility administrators rather than in hand service to a respondent.
  - National attention on conservators continues with a large concern on lack of court oversight and attention to mandated reviews and accountings. Please ensure that the court staff is using the alert system with consistent follow up to obtain compliance by fiduciaries and court-appointed attorneys.
- e. The recently distributed 2024 Probate Court Rules of Procedure manuals will be

replaced by the publishers due to errors in publication.

# 6. Comments of the President Judge:

Judge Darby complimented PCA with their assistance with training a new chief clerk in the Greater Manchester Probate Court. He discussed his frustration with challenges in finding individuals to serve as guardians and conservators in our court system. The judges shared their thoughts and frustrations as well.
