Attorney David Baram, was admitted to the Connecticut Bar Association in 1978. Attorney Baram was the Managing Member of his former law firm of Baram, Tapper & Gans, LLC.

David has many years of municipal and regional experience, having served as Mayor of Bloomfield (1983-1989), Chairman of the Capitol Region Council of Governments (1987-1989), President of the Bloomfield Chamber of Commerce (1997-1998), State Representative of Bloomfield/Windsor (2009-2017), and Chairman of the Bloomfield Center Fire District Board of Commissioners (2006 – 2017). David's years in government service have enabled him to develop a high level of experience in the areas of municipal law, land use and zoning, administrative hearings and appeals, and zoning litigation. His familiarity with the business community provides David with unique insight in the practice of business law, commercial and real estate transactions, employment law and probate/succession planning.
