The committee discussed a brief update on the upcoming seminar on March 14, 2024

- Case law update
- Informational presentation on Artificial Intelligence (AI) and the court system
- Informational presentation on Supportive Decision Making

The remainder of the meeting focused on discussion of the content of potential programs for the 2024 seminars:

June 26, 2024

- Judicial Branch Situational Awareness Training, including de-escalation techniques
- Review of Probate and Superior Court appeals process
- Potential presentation from the Connecticut State Library and Archives regarding the agency, probate records and related records topic
- Potential presentation for an in-depth review of discovery in Probate Court proceedings, particularly regarding various subpoenas in probate
- Firearms rights: the loss and restoration of firearms rights, NICS requirements

September 18, 2024

- Reinstatement of parents in guardianship hearings
- UCCJEA
- Overlapping jurisdiction and differences between Superior Court (Juvenile, Family, etc.) and Probate Court potentially coordinating with CBA Sections

October 23, 2024/November 20, 2024Annual Legislative Update

- "New" Probate Rules of Procedure (target July 2024 revisions)
- Interviewing techniques (targeted selection)
- Overlapping jurisdiction within the State (between Probate Courts)
- Judges' favorite statutes: potpourri of judges presenting and discussing their favorite probate statutes

- Retirement and maximizing benefits; challenges facing retirement, such as special elections for judges
