#### <u>Legislative</u>

Cindy Wolfe Boynton reported that PCA is preparing a summary of 16 bills that is some way touch Probate Courts. The summary will be shared with judges.

She highlighted a few acts that are of some significance and are effective July 1, 2023: Marriage Act, Budget, Elimination of fees on Name Changes, Probate Ops Bill, Exploitation of Seniors, Indian Child Welfare Act. # 5. Comments of the Probate Court Administrator:

Judge Streit-Kefalas explained that the Legislature and Governor did not approve our Budget as presented but approved the elimination of the sweep on June 30, 2023 from which there will be sufficient funds to cover the requested amount for FY24. Year 2 of the Budget was approved as requested. In addition to judicial compensation adjustments, the proposed budget includes the 3% merit compensation adjustements for July 2023 and proposed cost of living and compression adjustments for January 2024. If revenue continues to be favorable, these items will be presented to the Probate Court Budget Committee for review at the December 2023 Budget Committee meeting.

She reported on the successful passage of the health insurance parity statutory change that will amend CGS section 5-259(g) to reduce health insurance premiums share for probate employees and judges from 50% to 30% for the +1 and family plans. A chart of the savings has already been sent to staff and judges.

Judge Streit-Kefalas reviewed several of the other bills with passage dates of July 1, 2023. She asked all judges to thank their legislators for their outstanding support this session.

#### 6. Comments of the President Judge:

Judge Daly raised a few issues for discussion by the members:

She sought input on assistance for judges as a result of the cumulative effect of dealing with depressing issues. Judge Streit-Kefalas commented that third party bystander trauma is a real issue. Judge Lewis shared that her staff enjoys HEP videos on various wellness topics they view on some Fridays during lunch.

Judge Daly inquired if the Ethics Committee would consider reviewing ground rules on judicial recusals.
