1. Call to Order:

Judge Darby called the meeting to order at 9:47 a.m.

2. Approval of the Minutes:

A motion to approve the minutes of July 10, 2024, was made by Judge Anthony, seconded by Judge Gardner Riordan and approved.

- a. Evelyn Gonzalez will be reaching out to all committee chairs to set the dates for the 2025 meetings.
- b. Several courts have moved locations: Northeast Probate Court, Northeast

Regional Children's Probate Court, and Hartford Regional Children's Court.

- c. The Probate Rules of Procedure books are available and being distributed to all courts.
- d. Fall Clerks Roundtables commence on September 27, 2024. Judges and all court staff are encouraged to attend. It is a 3 hour session that fulfills half of the educational requirement for clerks and court staff.
- e. The Legislative session is already gearing up. PCA is meeting with stakeholders and preparing the next biennial budget. It is anticipated that the upcoming budget process will be challenging.
- f. There are special elections to be held November 5, 2024 in six Probate Districts.

6. Comments of the President Judge:

Judge Darby discussed the need to review the Bylaws of the Assembly. He and Judge Streit-Kefalas will set up a committee to update them. One area is the size of the Executive Committee.

Judge Darby also reminded all the next Assembly meeting next week on September 18, 2024. The afternoon is a joint bench/bar session.
