5. Comments of the Probate Court Administrator:

Judge Streit reminded the judges of the CMS Basics Webinar later in the day. She encouraged all to attend.

Judge Streit reported that PCA is conducting the biennial court visits for 30 courts this summer into early fall.

She also reported that the Governor has issued the three writs for the special elections to be conducted for probate judge positions on November 5, 2025, for West Haven, Farmington Regional and Madison-Guilford. Judge George Baker recently began his term in Windham-Colchester for the retiring Judge John McGrath. Judge Carolanne Rowe has assumed the position vacated by Judge McGrath as Administrative Judge for the Northeast Regional Children's Probate Court.

Judge Streit reminded the judges of policy manual changes as of July 1st and the recent communication regarding invoices that must be addressed by year end in preparation for the launch of the new CMS in 2026.

Finally, she highlighted that the new legislative bill authorizing DDS to petition for guardianship with authority to manage finances became effective upon enactment. She encouraged courts not to send out requests for review assessments to DDS all at once to allow the department to complete them timely.
