1. Call to Order:

Judge Darby called the meeting to order at 9:50 a.m.

2. Approval of the Minutes:

4. Committee Reports:

Continuing Education

Judge Lewis reported that the September program was well attended. She thanked the judges who participated. Upcoming educational programs will be held in October and November. The November program is a joint Bench/Bar program with the CBA. The next committee meeting is October 15, 2025 at 9 a.m. at PCA.

Ethics

- The Rules Committee for the 2026 edition of the Rules will have its last meeting to review the draft rules on October 9, 2025. The next step will be the public hearing with the goal for the revised rules to be effective July 1 2026.
- The § 7 Conservator Working Group's next meeting is October 20, 2025.

6. Comments of the President Judge:

Judge Darby commented on the following:

- He attended the first meeting of the Section 7 Working Group on Conservator Issues and remarked that it was an informative meeting and a good discussion on issues.
- He noted that he sits on the Planning Committee which is working on the bench guide for best practices for virtual attendance at hearings. He has found especially in certain case types and matters; there is better attendance when the hearing is fully in person rather than granting the ability for parties to attend virtually.
