# Overview of PA 25-48 § 7

Pursuant to Section 7, "the Probate Court Administrator shall convene a working group consisting of Probate Court judges, the Commissioner of Social Services, or the commissioner's designee, representatives of nursing homes, as defined in section 19a-563 of the general statutes, and attorneys having expertise serving as conservators, to study and provide recommendations on the issues facing conservators in the Probate Court system, including, but not limited to, delay of payments, fee waiver requirements and compensation levels. Not later than January 15, 2026, the Probate Court Administrator shall report on the results of the study in accordance with the provisions of section 11-4a of the general statutes to the joint standing committee of the General Assembly having cognizance of matters relating to the judiciary. Such report may include legislative recommendations relating to Probate Court procedures and the topics that were included in the study."

Judge Streit discussed a short history of the Probate Courts and their involvement with conservatorships and advancements, including the comprehensive statutory revisions in 2007 to ensure protection of due process rights, highlighting the mandatory Standards of Practice for Conservators and available online training tools.

Attorney Evan C. Brunetti, Deputy Director of External Affairs for the Office of the Probate Court Administrator, provided a presentation on the current laws and regulations relevant to conservator compensation in Connecticut.

After the presentation, the members began discussions on the statutory scope and charge from PA 25-48 for this working group. All members offered observations and put forth concerns surrounding the challenges faced by conservators. Moreover, the members had an exchange of perspectives for each of these observations and concerns. The members identified challenges in the following primary areas:

- Issues creating chilling effects on Conservator recruitment and retention
  - o Example, fee and payment structure
  - Example, quality of life balance
  - Example, risk of liability and litigation
- Barriers for requesting or granting a waiver of court fees and eligibility for statepaid fiduciary
  - o Example, form challenges, information gaps, timelines
- Barriers in evaluating compliance with regulations in order to facilitate proper payment of conservator fees from public funds
- Fiscal and budget challenges in implementing incentives for Conservator recruitment

Fiscal and budget challenges in implementing incentives for Conservator retention

Essentially, the next meeting of the working group will take primary areas and specifically identify and address those overall barriers and thus focus on increasing the availability of conservators.
