

CONNECTICUT PROBATE ASSEMBLY

REGULAR MEETING November 30, 2022

1. Call to Order

The meeting was called to order by Judge Daly at 12:25 p.m.

2. Pledge of Allegiance

Judge Jalowiec led the Assembly in reciting the Pledge of Allegiance.

Roll call of the Judges

Thirty-five judges were present at Courtyard by Marriott-Cromwell for the meeting. In addition, Probate Court Administrator Judge Streit-Kefalas, Attorneys Heather Dostaler, Evan Brunetti and Eric Rothauser and 14 judges-elect also attended.

3. Approval of the September 21, 2022 Meeting Minutes

A motion was made by Judge Wright and seconded by Judge Gardner Riordan to approve the minutes for the last Assembly meeting. The motion carried unanimously.

4. Treasurer's Report

Judge Randich reviewed the Treasurer's Report for the first quarter of the 2023 fiscal year. He noted 2 expenses for previous seminars. Judge Magistrali moved to approve the report and Judge DeGennaro seconded the motion. The motion carried unanimously.

5. Committee Reports

National College of Probate Judges (NCPJ)

The President Judge yielded the floor to Judge Yamin, the recently installed President of NCPJ, to explain the origin and purpose of the college. After a brief history, Judge Yamin encouraged all judges - new and old - to become active members. Dues for membership are paid by PCA for active, sitting judges. As President, her goals are to increase membership, partner with other associations, and work with bar associations across the country. The next conference is in Tucson, AZ in May 2023.

Continuing Education

Judge Brandt reported that the committee was scheduled to meet after the seminar on December 19, 2022. That seminar will be a primer on evidence. The first seminar in 2023 will be on January 26, 2023 on implicit bias, DDS services, and contested cases.
