

# CONNECTICUT PROBATE ASSEMBLY

### Regular Meeting January 24, 2024

### 1. Call to Order

The meeting was called to order by Judge Daly at 12:15 p.m.

#### 2. Pledge of Allegiance

Judge Randich reviewed the Treasurer's Quarterly Report for the quarter ending December 31, 2023. He noted that the only expenditures to date were for seminar expenses. Judge Barrett made a motion to approve the Treasurer's Report as presented. Judge DeGennaro seconded the motion, and it was unanimously approved.

Judge Lewis thanked the Judges for presenting at seminars. The next seminar is slated for March 14, 2024 at Quinnipiac University School of Law. The annual case law update, artificial intelligence, and supported decision making will be topics covered. The Committee is planning future seminars. #### Legislative

Judge Fox reported that the Committee met in December. PCA has met with the Judiciary Committee and presented the Probate Operations bill for review. The upcoming legislative session is a short session beginning on February 7, 2024. The next Committee meeting is February 23, 2024 at 9:00 a.m. in the Trumbull Town Hall.

#### Planning Committee

Judge Anthony reported that the Committee met on January 22, 2024 and work is ongoing to compile a bench guide of best practices regarding scheduling of hearings.

#### **Public Information**

Judge Wexler encouraged all to keep in touch with communities that the courts serve. The next Committee meeting is scheduled for March 1, 2024 at 1:30 p.m. in the PCA Library.

#### **Procedures Review**

Judge Berkenstock reported that the Committee last met on December 4, 2023. Many forms were reviewed. The name change for minor's decree was amended as well as creation of a new decree on financial holds. The next meeting is March 4, 2024 at 9:00 a.m. in the PCA Library.

#### **Court Security**

Judge Calabrese reported that the last meeting was December 4, 2023. The Committee has received a few additional security assessments, but more courts need to comply. The Committee will be sending a survey to all judges and chief clerks to get a sense of issues that need to be addressed. More representation from judges and chief clerks is needed on the Committee. The judges had a discussion about the prohibition of weapons in the courts. Judge Streit-Kefalas

encouraged interested judges to join the Security Committee to further discuss the issues. The next Committee meeting is February 5, 2024 at 10:00 a.m. in the PCA Library.

- f. The Probate Ops bill has been presented to the Judiciary Committee Co-Chairs. The session begins in 2 weeks. She will be sending out talking points for judges to use when speaking with their representatives. Restoring the name change filing fee is a priority. Judge Lewis was recognized for hosting an open house at her court for local and state legislators and educating them on the needs of the probate courts.
- g. Congratulations to Judge Daly on receiving the prestigious Ladder Award from the CBA Women's and Young Women's section for her promotion of women in the legal field. The award's ceremony is set for March 7, 2024 at the Aqua Turf Club. All are encouraged to attend.
