MINUTES OF REGULAR MEETING January 28, 2026

1. **Call to Order**

The meeting was called to order by Judge Darby at 12:52 p.m.

2. **Pledge of Allegiance**

Judge Anthony led the Assembly in reciting the Pledge of Allegiance.

3. **Approval of the October 22, 2025 Probate Assembly Meeting Minutes**

A motion was made by Judge Hoyle and seconded by Judge DaSilva to approve the minutes of the last Assembly meeting. The motion carried unanimously.

4. **Treasurer's Report**

Judge Randich presented the Treasurer's Report for the second quarter of the fiscal year ending June 30, 2026. A motion was made by Judge DaSilva, seconded by Judge Landgrebe and unanimously carried out to approve the Treasurer's report as presented.

5. **Proposed Revisions to the Bylaws**

Judge Darby reported that the Bylaws Committee has proposed changes to the Bylaws for approval by the Assembly. A motion to approve the changes was made by Judge Anthony and seconded by Judge Hoyle and unanimously approved.

6. **Report of the Nominating Committee**

Judge Anthony reported that in accordance with the revised Bylaws just approved by the Assembly, the Nominating Committee has nominated a slate of officers, Executive Committee members and members of the Probate Court Budget Committee for election to be voted on at the Assembly Annual meeting in April. There were no nominations from the floor. A motion to close the nominations was made by Judge Carchia and seconded by Judge Szewczyk. The motion carried unanimously. This slate will be elected at the Annual Meeting as no nominations may be made at the annual meeting.
