# Approval of minutes of June 26, 2025 meeting

A motion to approve the minutes was made by Hon. Kathleen N. Maxham and seconded by Hon. David C. Shepard. The minutes were approved by all members of the committee present at the meeting without change.

## Review of concepts for revision for the 2026 edition

The Committee continued to review the proposed concepts for rules presented at the last meeting. The full committee offered feedback on the following topics:

• Regarding adoption of a rule to clarify when a social security number is required for a petition, the committee reached consensus to make no changes to the rule.

- Regarding the proposal to review Rule 21, Probate Mediation, there was consensus to make no changes to the rule.
- Regarding the proposal to make eFiling mandatory under Rule 22.3 for any conservator paid by the Probate Court Administration Fund, there was consensus for draft language to be prepared and reviewed for incorporation in the 2026 revisions.
- Regarding mutual distribution agreements under Rule 30.17 and definition of "party" under Rule 1.1(27), the proposal was tabled for further discussion.
- Regarding adoption of notice of bond/restriction on assets procedure to replace limited fiduciary certificates in Rules 35.2 and 35.7, respectively, there was consensus that draft language should be prepared and reviewed for incorporation in the 2026 revisions.
- Regarding records to be maintained by fiduciary under Rule 36.13, there was consensus that draft language should be prepared and reviewed for incorporation in the 2026 revisions.
