- To draft and further review revisions to Rule 42 to incorporate the current protocol among the Office of the Probate Court Administrator, the Department of Children and Families and the Superior Court-Juvenile Matters.
- To make no changes to Rule 1.1(15).
- To repeal Rule 2.2 relating to applicability of Probate Court Rules of Procedure to probate appeals, subject to advisement by the Probate Court Administrator.
- To make no changes to streamline procedures under Rule 8.6(h).
- To draft and further review revisions to Rule 30.17 for consistency with C.G.S. § 45a-434(c).
