- To include the importance of civility toward the judiciary and parties in a matter in the Probate Court Administrator's Preface to the rules rather than adopting principles of civility/professionalism at this time.
- To review the rules for gender-neutral language and revise if necessary to ensure gender-neutrality.
- To make no changes with respect to generative artificial intelligence at this time.
- To make no changes to Rule 66 at this time.
- To draft a new rule to address procedures for taking out-of-state depositions relating to probate matters.
- To draft and further review revision to Rule 61.3 relating to taking depositions in Connecticut with respect to probate matters.
- To draft and review revisions to Rule 45.5 relating to where a petition for electroconvulsive (shock) therapy may be filed.
